****NCNB puts money and muscle behind University Hospital Corporate Partnership Campaign

NCNB Texas has committed \$100,000 to the Corporate Partnership Campaign that has been launched to raise funds to complete the Zale-Lipshy University Hospital, hospital President Ronald F. Garvey, M.D., M.B.A. announced today. The money will be used to equip a private intensive care unit in the hospital.

The Zale-Lipshy University Hospital is a 160-bed private referral, teaching and research hospital at The University of Texas Southwestern Medical Center at Dallas and is scheduled to open in late 1989.

The fund-raising campaign was launched last October by the Development Committee of University Medical Center Inc., the private nonprofit corporation established to build and operate University Hospital. The Development Committee established a goal of \$10.8 million -- the amount needed to complete the construction of the hospital. With that goal in sight, the Committee has launched a Corporate Partnership Campaign to raise the remaining money. The campaign's goal is to raise \$4.5 million by Nov. 1.

Joseph R. Musolino, vice chairman, Dallas, NCNB Texas, is the general chairman of the Corporate Partnership Campaign for University Hospital. "The corporate community recognizes that University Hospital and UT Southwestern Medical Center are key elements in establishing Dallas as an internationally recognized medical referral center," he said.

More than 300 major Dallas businesses will be invited to participate in the corporate campaign. "We're going to be knocking on a lot of doors over the next few months," said Musolino.

Hart, special consultant, Bramalea Texas; E.J. "Pete" Joost, executive vice president, NCNB Texas; James B. Gardner, vice chairman, Banc One Texas; Robert Campbell, managing partner in charge, Touche Ross; John B. Lowe, chief executive officer, Texas Industries; Terry M. Wilson, vice chairman, Texas Commerce Bank; John J. Veatch Jr., managing director, Salomon Bros. Inc.

The other officers of University Hospital are Ralph G. Greenlee Jr., M.D., chief of staff; Royce Laycock, M.D., vice chief of staff; and William Gary Reed, M.D., secretary/treasurer. The three were elected by the 200-member medical staff of the hospital.
