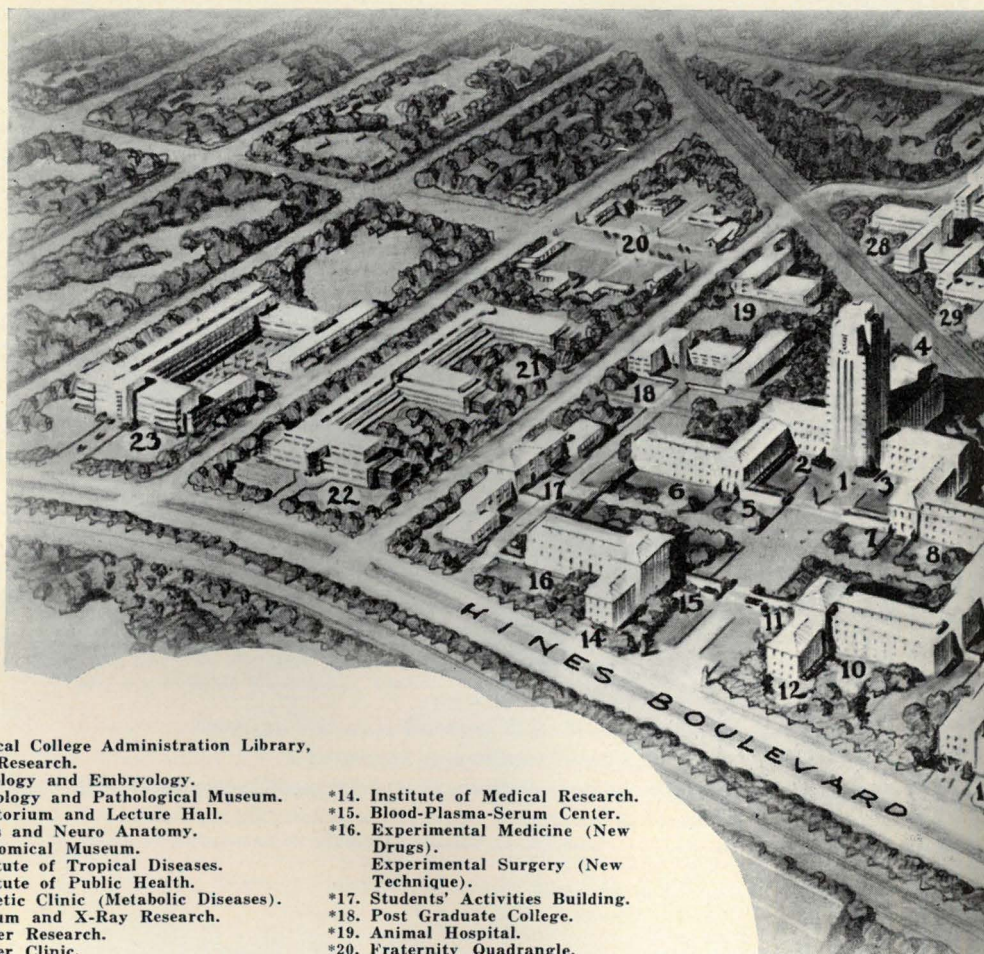

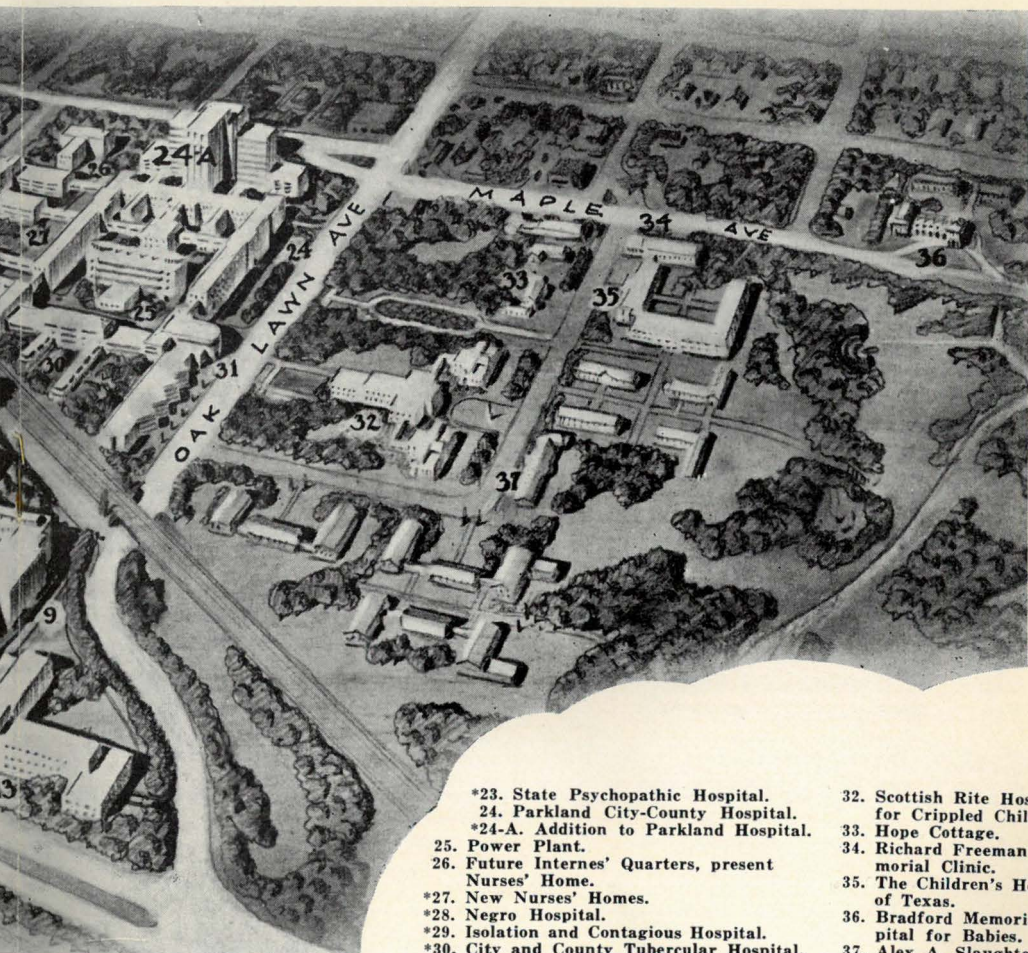
SOUTHWESTERN MEDICAL CENTER AT DALLAS SHOW

In the sketch above, architect George H. Dahl depicts the Southwestern Medical Center being developed through the activity of the Southwestern Medical Foundation on twenty-four acres of land adjoining the site of eleven acres now occupied by Parkland Hospital (City-County) with 450 charity beds.

The total area of thirty-five acres is bounded approximately by Hines Boulevard in the foreground of the picture, paralleled by Maple Avenue in the background beyond Parkland. On the south (right) is Oak Lawn, with a frontage of 1,700 feet northward (to the left) along Hines Boulevard to Knight Street.

One block to the south is a successfully functioning pediatrics center of 125 charity beds, including Scottish Rite Crippled Children's Hospital, Texas Children's Hospital, Freeman Memorial Clinic, Bradford Hospital for Babies, and Hope Cottage.

Stimulating nucleus of development in the new area of the Medical Center will be a building

AVING BOTH THE PROPOSED AND EXISTING BUILDINGS

for the School of Medicine with a large auditorium or amphitheater to the rear. Joining the medical college building to the north and south will be smaller buildings for research and special clinics. A dental college-clinic structure, library and students' activities building complete the teaching units.

To the extreme north from the medical buildings, on Hines, is a site for a State Psychopathic Hospital, as designated for Dallas by the Legislature some years ago when a similar institution was built elsewhere. The next Legislature is expected to appropriate funds for the Dallas hospital.

Between the site for the State institution and the medical buildings is an ideal location for a tuberculosis hospital, for which a bequest of approximately \$800,000 is available.

The role of the Southwestern Medical Foundation is to make sites available for the varied enterprises and to coordinate their efforts in medical research and teaching.

HISTORY AND PURPOSE

DALLAS, in the very heart of the great Southwest, for several decades has been acknowledged by medical educators to be the most challenging spot in the nation for the development of an outstanding medical school and medical center.

From several proprietary medical schools existing in Dallas at the beginning of the twentieth century emerged the so-called Medical Department of the University of Dallas, under the leadership of that future president of the American Medical Association, Dr. E. H. Cary, Dr. C. M. Rosser, and a handful of similar scientific stalwarts. Eventually, to stabilize the school, in 1903 Dr. Cary voluntarily offered it to Dr. S. P. Brooks and Baylor University, and the latter institution sponsored medical education in Dallas until 1943. Southwestern University's Medical school, and in turn the medical department of Southern Methodist University, helped to occupy the field for several years. In 1918 the Fort Worth Medical College, which had been sponsored by Texas Christian University, merged with the only remaining medical school in Dallas.

For years an increasing number of capable teaching clinicians and a faithful band of pre-clinical teachers labored courageously against tremendous handicaps of meager equipment and financial support to turn out over 1,500 competent graduates who have acquitted themselves creditably all over the world. Time and again the standardizing agencies called attention to material deficiencies, but always the persuasive optimist, Dr. Cary, promised that substantial resources would be supplied by the people of the Southwest. In 1941 the first new building on the campus since 1907 was built and paid for by the alumni and other doctor friends.

Eventually Dr. Cary envisioned the solution of the problem in a broad medical foundation, under non-denominational control, with that universal appeal to all people to support the humanitarian project of medical research and medical education. He gathered around him a small group of far-seeing business men and philanthropists, and on January 21, 1939, there was chartered the Southwestern Medical Foundation.

Then followed several years of careful analysis and planning, with support given meanwhile to a Blood Plasma and Serum Center, and a Venereal Disease Clinic, both of which projects won national renown. Two principles became clear: (1) the medical center should be developed adjacent to the existing Parkland City-County (charity) Hospital and the near-by Pediatric Center with its Scottish Rite Crippled Children's, Texas Children's and Bradford Memorial Hospitals, Freeman Memorial Clinic and Hope Cottage; and (2) it would be desirable to conserve what had been accomplished in medical teaching in Dallas by providing a new and adequate home and support to the medical school then existing in Dallas.

Eventually, in June, 1942, the Southwestern Medical Foundation made a contract with Baylor University whereby the latter's college of medicine should be given new buildings, equipment, and financial support in the new center, with academic relations remaining undisturbed. An Administrative Committee was appointed for the medical school of five members, three of whom were from the Foundation.

Some of the trustees of Baylor University evidenced increasing unhappiness and finally, on April 27, 1943, declared cancelled their contract with the Southwestern Medical Foundation, and soon thereafter announced that they were moving Baylor medical and dental colleges to Houston at once.

All of the approximately two hundred clinical teachers, all of the pre-clinical teachers except five, and over 90 per cent of the students immediately asked the Southwestern Medical Foundation to preserve medical education in North Texas by establishing a Class A medical college in Dallas, offering their hearty cooperation and support. The trustees of the Foundation acceded to the request and, with the cooperation of the citizenry of Dallas, formally launched a College of Medicine on May 5, 1943. With the war on, the training of approximately 300 future medical officers for the army and navy could not be delayed a single week. The Foundation, with the aid of the medical teachers and students, accepted the herculean task of organizing and equipping a Class A school to open June 21—and the job was done.

Fortunately, in March, 1943, the Foundation had concluded with the Dallas city and county officials a twenty-five-year contract for access to Parkland Hospital for medical teaching. Arrangements were

made for over 25,000 square feet of space in prefabricated buildings adjacent to Parkland. With the true Dallas spirit, the Board of Education offered the beautiful new Alex Spence Junior High School building for use during the summer months, so that the students would be spared the inconveniences of attending classes in buildings being rushed to completion.

In 1942 the Foundation bought twenty-five acres of land between Parkland Hospital and Hines Boulevard as the site for the new Southwestern Medical Center, augmenting the eleven acres occupied by Parkland Hospital. In 1943 the trustees of the Foundation invited the citizens of Dallas to provide an initial \$1,500,000.00 for the launching of the new school. The directors of the Dallas Chamber of Commerce and Citizen's Council heartily and unanimously endorsed the project and pledged a fund of at least \$100,000 a year for not less than ten years toward the operation of the school and Medical Center.

The Southwestern Medical Center will have eventually at least \$10,000,000.00 in buildings; and the goal is set for at least \$15,000,000.00 in endowments. Major construction will have to await the end of the war and the lifting of building restrictions. Meanwhile the same determined, capable medical teachers, clinical and pre-clinical, will go right along inspiring and training the same ambitious young men and women in Dallas, so that medical education and research in North Texas and the Southwest may reach heights never dreamed of before.

GENERAL INFORMATION

ORGANIZATION

By its charter, the Southwestern Medical Foundation is authorized to carry on medical education and research. Accordingly, in May, 1943, the trustees authorized the officers of the Foundation to organize and launch a School of Medicine. Between the annual meetings of the Foundation, business matters concerning the school are handled by an Executive Committee of the Foundation. The internal management of the School of Medicine is delegated to the Dean and an executive committee. This executive committee of the school makes such recommendations as deemed wise from time to time, to the Foundation through the Dean of the School.

HOSPITALS

PARKLAND HOSPITAL is jointly controlled by the city and county of Dallas and has a capacity of approximately 400 beds. All the clinical facilities of this hospital and its dispensary are available to the School of Medicine throughout the entire year. This hospital affords a varied and interesting group of cases which are used for instruction of the students in the clinical years.

WOODLAWN HOSPITAL, controlled jointly by the city and county, is used exclusively for the care and treatment of tuberculous patients. The hospital affords facilities for the demonstration of all stages and types of the disease as well as the various methods of treatment.

BRADFORD MEMORIAL HOSPITAL is located near the Parkland Hospital and has a capacity of forty beds. Poor children of the city under two years of age are admitted. Senior students receive here part of their clinical teaching in Pediatrics. Excellent facilities are available for the teaching of infant feeding in all its different phases.

CRIPPLED CHILDREN'S HOSPITAL, owned and controlled by the Masonic bodies of Texas, has a capacity of sixty beds and is located across the street from Parkland Hospital. This hospital affords a varied and interesting group of orthopedic cases which are used for instruction to the senior class.

TEXAS CHILDREN'S HOSPITAL and the FREEMAN MEMORIAL CLINIC, with their excellent facilities and teaching material, are used for observations and practical work in Pediatrics by the senior class.

PARKLAND HOSPITAL DISPENSARY

The out-patient dispensary of Parkland Hospital occupies the first two floors and part of the third floor of the south wing of the hospital building. The out-patient department is designed to care for the indigent patients of Dallas County who do not require hospitalization. The great majority of the indigent patients are registered in this out-patient dispensary. In the past four years there have been approximately 214,000 patient visits yearly. All patients are available for teaching purposes.

The out-patient dispensary is divided into the following services: Social service department, laboratory, and the departments of medicine, surgery, obstetrics, gynecology, urology, cystoscopy, orthopedics, oto-laryngology, ophthalmology, dermatology and syphilology, pediatrics, proctology, neuro-psychiatry, tumor clinic, and the medical specialties of allergy, diabetes, endocrinology, cardiology, gastro-enterology and chest diseases.

The students are required to record the history, do a complete physical examination, recommend diagnostic and therapeutic measures, and do minor surgical procedures. The activities of the students are under the supervision of a clinical instructor who is present in each out-patient clinic. The patients are followed in the clinic to determine the results of treatment. This is made a part of the permanent record.

The unit record system is employed in this hospital. This combines the hospital chart and dispensary record. Those patients who require complicated diagnostic procedures are admitted to the hospital. The student may follow the patient's progress in the hospital as well as in the out-patient dispensary. The bed capacity of Parkland Hospital is approximately 400 beds. This is adequate to admit any clinic patient in need of hospitalization.

The senior class is divided into small sections, and by rotation each section has a service in each out-patient department.

INFORMATION FOR PROSPECTIVE STUDENTS

FOR THE duration of the war applications will be considered at any time after the completion of one full session of pre-medical college work for admission at the first registration date after all requirements are met.

REQUIREMENTS FOR ADMISSION

The Committee on Admissions has adopted the following pre-medical requirements, to continue in effect for the duration of the accelerated program and longer if circumstances then require it.

1. *Chemistry*: Inorganic, 8 semester hours; Organic, 4 semester hours; Quantitative, 3 semester hours.

2. *Physics*: 8 semester hours, including mechanics, heat, sound, light and electricity.

3. *Biology*: 8 semester hours. General and Vertebrate (not including botany).

4. *English*: 1 academic year.

5. *Electives*: Sufficient to complete 2 academic years.

The candidate's pre-medical work must therefore include at least 60 semester hours, completed in an approved college of arts and sciences, and must show a general average, as computed by the Committee on Admissions, of C+ or better.

Candidates entering the school under the Army-Navy Specialized Training Program must present hours as specified by the Army-Navy.

APPLICATIONS FOR ADMISSION

Each applicant must present the following:

1. A formal application for admission on a form furnished by the Registrar.

2. An application fee of \$5.00 must accompany this formal application.

3. An official transcript of the college record. This should show (a) certified high school credits; (b) college courses completed, with credit hours; (c) subjects the applicant is taking or will take to complete his pre-medical training before registration in medical school. Medical aptitude test should be taken.

4. A recent, unmounted photograph, about 3 x 4 inches.

After a student's credentials have been received the Committee on Admissions examines them and notifies applicants of its decision as soon as feasible.

Accepted candidates must deposit with the Registrar the sum of \$50.00, in the form of cashier's check or post office money order, within two weeks from date of notification of their acceptance. This deposit is not returnable, but is credited toward the first tuition payment.

Credentials of accepted students become the property of the School.

All communications regarding admission to any class of the Southwestern Medical Foundation School of Medicine should be addressed to the Registrar.

REGISTRATION

All students are required to register in person at the beginning of each session. For the session 1943-44 the registration period will be June 21 to June 30. Students paying fees due for the trimester after June 30, 1943, September 27, 1943, January 3, 1944, will be charged a delayed payment fee of \$2.00. In no case will a student be allowed to register later than Monday, July 5, 1943. No student will be permitted to do class work until registered. No student will be allowed to register until application has been completed and officially approved.

The School reserves the right to refuse registration to any student and also the right to correct any mistake in classification occurring under misapprehension in registration.

RULES AND REGULATIONS FOR EXAMINATIONS AND CLASS STANDING

The minimum passing grade is 70 per cent. Grades of 60 per cent to 69 per cent, inclusive, are a condition; below 60 per cent, failures. A grade once entered will not be changed. Students are given their grades indicated by letter as follows: A, 90-100; B, 80-89; C, 70-79; D, 60-69, inclusive, condition; F, below 60, failure.

Students failing in two or more courses or conditioned in three or more or the equivalent thereof must repeat the work of the year or years in which such deficiencies occurred if their readmission is approved by the Committee on Advanced Standing. A student who has this number of deficiencies at any time during the session shall be required to withdraw for that session. Students receiving conditions in not more than two courses shall be eligible for re-examination in these courses at the regular time set for such supplementary examinations. The instructor in the course in which such condition occurs may require any additional work from the student which he thinks necessary. A student who drops a course without permission of the Dean and the instructor shall be considered as having failed in such course.

For each supplementary examination a fee of \$3.00 must be paid.

A student who fails to appear for re-examination at the regular appointed time for such examinations forfeits all privileges of re-examination and shall be considered as having failed unless it can be shown such student had sufficient reason for such absence. The student will be granted the privilege of a special re-examination, if the Committee on Advanced Standing decides such reasons are sufficient.

A condition not removed on re-examination becomes a failure. Any student permitted to repeat the year's work and failing a second time shall be denied further registration in this School. No student is permitted to carry a deficiency beyond the year succeeding that in which such deficiencies occurred nor to carry a deficiency beyond the junior year. Students required to repeat a course will not be permitted to carry any advanced work which conflicts with the course in which such deficiency exists nor any courses to which the deficient course is a prerequisite.

Regular attendance in all courses is necessary. Attendance of at least 90 per cent of the scheduled work in each course is required. It is not to be understood that this rule would permit a student to constantly attend only 90 per cent of the work during the session.

The School reserves the right to dismiss any student whose attendance in the school it deems inadvisable.

ADMISSION TO ADVANCED STANDING

Advanced standing to the second or third year classes may be granted, if vacancies exist, to those who have completed the necessary entrance requirements and medical courses equivalent to those given in this school in the year or years preceding that to which admission is desired.

Students with scholastic deficiency are not considered.

Applications for advanced standing consist of proper application blank, complete official transcript of entrance and medical school credits, and letter of honorable dismissal from the medical school last attended. The application must be accompanied by a cashier's check or money order for \$50.00, made payable to the Southwestern Medical Foundation. This remittance will be applied on the tuition fee if the applicant is accepted, forfeited should he fail to keep his appointment, and refunded should he not be accepted.

VACCINATION

All students are required to be satisfactorily vaccinated against smallpox and are urged to submit to vaccination against typhoid-paratyphoid fevers.

DISCIPLINE

Negligence, habitual absence from the assigned work of the institution, and irregularity of conduct are by regulation made sufficient basis for suspension or expulsion.

LEAVE OF ABSENCE

Students who withdraw from the School of Medicine without notice or who fail to report after a leave of absence will have their connection with the School of Medicine terminated.

MICROSCOPE

Students are advised to purchase their own microscopes, but those who do not care to do so may rent one from the School at a cost of \$10.00 per session. Students using microscopes which belong to the School are liable for damage done the instrument while in their possession.

MILITARY TRAINING

The student military training program of the Southwestern Medical Foundation School of Medicine will be announced as soon as proper authority has been given by the Army and the Navy.

REQUIREMENTS FOR GRADUATION

The candidate for the degree of Doctor of Medicine must have attained the age of 21 years and must be of good moral character. He must have attended four sessions as a regular matriculated student, the last two of which have been spent in this School. He must have completed the required work, have received a satisfactory grade throughout the entire medical course, and have fulfilled satisfactorily all special requirements. He must have discharged all indebtedness to the institution.

CURRICULUM

GENERAL PLAN OF INSTRUCTION

The academic year is divided into trimesters. Each trimester is of eleven weeks' duration. The general plan of instruction has for its object the preparation of students for the practice of general medicine. The course is divided into two periods of two years each. The first period is devoted chiefly to the fundamental medical sciences, Biochemistry, Anatomy, Physiology, Bacteriology, Pharmacology, and Pathology. The practical application of these to clinical medicine is stressed and emphasized at all times. The second period is devoted chiefly to the clinical subjects—Medicine, Surgery, Obstetrics, and the specialties. There is no sharp dividing line in the teaching of the so-called pre-clinical subjects and the clinical subjects.

Lectures, quizzes, and laboratory exercises are conducted in a manner designed to incite in the student any practical originality that he may possess. He is encouraged by these methods and guided by those in charge to assume the initiative so necessary in reducing to a minimum his dependence upon others. The student's attention is constantly called to the value of learning well the facts upon which greatest emphasis is placed, so that he may the better be enabled to discard the non-essentials.

First Year

COURSE I—HISTOLOGY AND EMBRYOLOGY—264 hours. First and second trimesters.

This course consists of lectures, recitations, demonstrations, and laboratory work.

The developmental history of the organ is considered in advance of the microscopical anatomy. The attention of the student is directed to the bearing of the embryological phenomena upon clinical subjects. In embryology a systematic study of the human development is carefully considered. This is supplemented by the study of serial sections of the 10 and 30 mm. pig embryos and the study of gross human embryos. Attention is given to the cause of malformation and anomalies.

Following the study of embryology, the minute anatomy of the cell and the intrinsic structure of the fundamental mammalian tissues are considered in preparation for the study of their interrelations as component parts of the organs and organ systems. The greater part of the course is devoted to the study of the architecture and detailed structure of the adult organs. Throughout the course the interrelationship of structural condition and functional activity is emphasized.

COURSE II—GROSS ANATOMY—380 hours. Throughout the session.

This course consists of dissections, supplemented by frequent conferences, and practical demonstrations. Each group, usually composed of four students, dissects the entire body, except the central nervous system, which is studied during the first trimester of the second year.

The work is conducted under the careful supervision and guidance of members of the staff. Ample dissection instructions are provided to the end that poor dissections are reduced to a minimum. Great emphasis is laid upon the importance of clean dissections and the value of learning anatomy from the actual specimen rather than from charts and drawings. The latter are used only as adjuncts to the former. Models and mechanical demonstrations are used whenever necessary to create a thorough understanding of the part being studied, and specially prepared radiographs of the thoracic and abdominal viscera are utilized. The osteology of a given region is taught at the time of the dissection of that region, so that the student may be able to fix this portion of anatomy into its logical place in the anatomy of the body as a whole. A complete set of bones is provided each student for home study. Small groups of students are frequently quizzed, and every individual of each group is required to demonstrate the relations of the structures under discussion. Much emphasis is placed upon regional and functional anatomy. Frequent review quizzes are conducted covering various portions of the work done during the year, in order that the student may be fairly conversant with practically every part of the body at the end of the course.

Topographical Anatomy is given in conjunction with Gross Anatomy. While a given region is being dissected, cross-sections, models, and special dissections are utilized for demonstration and study of

that particular region. Every student is required to pass a practical examination on selected cross-sections at the discretion of the instructor.

Second Year

COURSE III—ANATOMY OF THE CENTRAL NERVOUS SYSTEM AND THE ORGANS OF SPECIAL SENSE—90 hours. First trimester.

This course consists of lectures, recitations, demonstrations, and laboratory work. Some of the more important phases of the development of the human nervous system are reviewed. Many specially prepared histological sections are studied along with gross dissections of the brain in the demonstration of the various fiber tracts and associated nuclei of the brain and cord. Each student is required to construct a chart showing the more important fiber tracts of the cord and brain-stem. The functional relationship existing between neurons and neuron chains is constantly emphasized. Wherever possible pathological slides and mechanical charts are utilized to demonstrate the various functional fiber tracts of the brain-stem and spinal cord. Clinical application of the anatomy of the nervous system in selected cases is undertaken in so far as it is deemed practical. The blood supply of the brain and its relation to various pathological conditions of the nervous system are given much attention.

COURSE IV—APPLIED ANATOMY—48 hours. Second and third trimesters.

This course is designed to emphasize those features in anatomy that have direct application to the practice of medicine and surgery. The instruction consists of laboratory work, demonstrations, and recitations. Use is made of cross-sections of the human body, special dissections, special preparations, and the living body. The head and neck and extremities are covered in this course. The clinical departments cooperate with the Department of Anatomy in this course.

Third Year

COURSE V—APPLIED ANATOMY—24 hours. Two hours per week during the first trimester.

This course is a continuation of Course IV, and includes the thorax, abdomen and pelvis.

First Year

COURSE I — BACTERIOLOGY AND IMMUNOLOGY — 187 hours. Third trimester; five lectures, five laboratories, one quiz section weekly.

A survey of micro-organisms pathogenic for man and of the mechanisms by which the body resists infectious diseases. The course emphasizes the nature of virulence, the methods of identifying pathogenic bacteria, and the mechanism of active and passive immunization.

Second Year

COURSE II—PUBLIC HEALTH—30 hours. First trimester; three lectures weekly.

A study of the methods by which the community provides for health control.

Third Year

COURSE III—PREVENTIVE MEDICINE—30 hours. All three trimesters, one lecture weekly.

A study of the epidemiology and control of communicable diseases.

COURSE IV—TROPICAL MEDICINE—20 hours. Third trimester; two lectures weekly.

A course in the diagnosis, treatment, and control of infectious diseases prevalent in the tropics. The course will stress the significance of these diseases to the health of the armed forces.

PHYSIOLOGY AND PHARMACOLOGY

In this department an effort is made to teach the purely scientific aspects of the subjects of Physiology and Pharmacology and to acquaint the student with the application of the fundamental principles of these subjects to the practice of medicine.

Second Year

COURSE I—PHYSIOLOGY—243 hours. First and second trimesters.

This course consists of lectures, conferences, quizzes, laboratory work, and demonstrations. Emphasis is placed on the understanding and correlation of facts and principles rather than pure memorization.

The course begins with a consideration of the physiology of muscle and nerve and instruction in the use of the standard physiological laboratory equipment. This is followed by a more comprehensive study of the physiology of blood, circulation, respiration, digestion, metabolism, excretion, and the central nervous system, the special senses, and the glands of internal secretion.

COURSE II — PHARMACOLOGY — 172 hours. Second and third trimesters.

This course begins with a study of the source, the physical and chemical properties of crude drugs, the active principles of plants, and a consideration of the pharmaceutical preparations in common use. The laboratory work includes class experiments on cold-blooded and warm-blooded animals, illustrating the responses of the organism to drugs and the methods of pharmacological experimentation. The results are discussed and systematized in conferences. Especial emphasis is directed to the therapeutic application and the toxicological effects of the drugs studied.

Fourth Year

COURSE III—APPLIED PHARMACOLOGY—9 hours. Third trimester.

The aim of this course is to show the relation of scientific pharmacology to the art of therapeutics.

First Year

COURSE I—BIOCHEMISTRY—200 hours. Second trimester.

The lectures are devoted to a discussion of the fundamental properties of solutions, carbohydrates, fats, proteins, enzymes, and the processes of digestion, absorption, and intermediary metabolism; the chemistry of the blood, respiratory metabolism and neutrality regulation, tissues, secretions, nutrition, and urine. In lectures and conferences are outlined those subjects which the student is expected to pursue by his own systematic reading. The laboratory work consists of the qualitative and quantitative examination of the substances treated in the lectures.

It is urged that students review the fundamental laws and theories of chemistry before beginning the course, since their success in this course is largely determined by such knowledge gained in their pre-medical training.

Second Year

COURSE II—PATHOLOGICAL CHEMISTRY—20 hours. First trimester.

An attempt is made to guide the student in a thorough review of the fundamentals of biochemistry and to bring the subject matter up to date by reviews of more recent articles on that subject. A rational explanation for the chemical processes underlying physiological function and pathological dysfunction is sought in order that the student may have a clearer understanding of the significance and limitations of the results of laboratory investigation.

COURSE III—RESEARCH IN BIOCHEMISTRY.

Open to a limited number of third and fourth year medical students or graduates who are properly qualified to pursue original investigations, at the discretion of the chairman of the department.

Instruction in Pathology is given in the second, third, and fourth years. While the basic principles of Pathology are studied from the viewpoint of gross and microscopic tissue organ changes, stress is also placed on functional and chemical correlations, and possible clinical manifestations. An abundance of fresh specimens from current autopsies and surgical operations is available for gross and microscopic study.

Second Year

COURSE I—GENERAL AND SPECIAL PATHOLOGY throughout the year
—285 hours.

A practical course for second year students, covering the principles of Pathology, and including a systematic study of the diseases of the main organs. Detailed consideration is given to the infective granulomas and neoplasms.

Illustrative material is available as fresh tissue specimen from operating rooms and autopsies.

The major part of the laboratory work consists of the study of sections illustrating all of the main lesions produced by disease, and this work is closely correlated with the lectures and recitations.

COURSE II—CLINICAL PATHOLOGY—160 hours.

This course is designed to emphasize the application of the basic medical sciences to the clinical problems of diagnosis, prognosis, and treatment. It covers the examination of blood, spinal fluid, gastric contents and other body fluids and products suitable for laboratory studies.

The practical and theoretical aspects of human blood and intestinal parasites of the tropical and sub-tropical regions, along with certain phases of medical entomology, are included.

The above material is presented in lectures, laboratory exercises and demonstrations.

Third Year

COURSE III—SURGICAL PATHOLOGY—10 hours. Third trimester.

A lecture and recitation course covering the special pathological processes related to surgical conditions. The course aims to emphasize the relation between the clinical picture and the pathological changes.

Fourth Year

COURSE IV—AUTOPSY TECHNIC AND RECORDS.

Members of the fourth year class witness autopsies occurring at Parkland Hospital. The clinical history is reviewed at the time of autopsy and an attempt made to correlate it with the anatomic changes found.

COURSE V—CLINICAL PATHOLOGICAL CONFERENCE—48 hours.
Throughout the entire session.

At each weekly conference one carefully selected clinical record is studied as a diagnostic problem. Representative clinicians from the various departments participate in the discussion without any knowledge of the autopsy findings.

MEDICAL ART AND VISUAL EDUCATION

Medical Art is the application of Art to Medicine. The qualifications of a medical artist are a thorough training in art, with an equally thorough understanding of the basic sciences of medicine and their applications to clinical medicine. The department incorporates the full use of art as well as the use of photography in illustrating the research of the pre-clinical and clinical departments of the school. The department holds that the proper recording of the findings of research is as important as doing the research.

The department files and stores these recordings, drawings, illustrations and photographs.

Medical Visual Education

The departmental auditorium is to be used by all the departments of the Medical Center when it is necessary to project motion pictures

or lantern slides for classes. The department also informs the heads of all other departments when films are made that are procurable for teaching and consults with them on the value of said films. The heads and members of the various departments then advise this department as to whether such films shall be made a part of the permanent library of films maintained by the Art Department.

This department is the custodian of all visual education equipment, attends to its proper maintenance, and provides whatever personnel is necessary for projection of moving pictures, lantern slides, etc. The desirable feature of owning teaching films is that a record of all such films may be kept in the several departments so that there is assurance that the film called for will be available when wanted, to fit into the teaching schedule.

Teaching Students in Medical Illustration

A class room and laboratories will be provided for a limited number of students who may be accepted for training in art as applied to medicine, photography, photomicrography and medical visual education. These students will be allowed to attend classes in anatomy, pathology, etc., so that they will be well-grounded in the basic sciences of medicine. Upon completion of the course in medical art, they will be issued a proper certificate.

Applicants must be high school graduates with at least two years' additional training in an accredited art school. Drawings of sufficient merit may be accepted and used by the department for publication and demonstration by the medical profession and as a practical test of the artist's ability. This course continues during the entire day throughout the academic year.

The instruction given by the Department of Medicine consists of lectures, clinics, practical work in the out-patient departments and wards of the hospitals, and special emphasis on laboratory diagnosis. There is a correlation of the clinical aspects of the patients with fundamental principles derived from the basic sciences. An effort is made to establish in the student's mind the importance of care and precision in diagnostic and therapeutic methods.

Second Year

Instruction in medicine begins in the second year with a course in physical diagnosis and general clinics and is continued throughout the third and fourth year. During the latter two years the course consists of lectures, recitations, a study of case histories, clinical conferences, practical clinical laboratory work, and studying and examining the patient at the bedside.

Third Year

Throughout the third year the subjects of internal medicine are covered by clinics or lectures for the entire class, which are given at the various hospitals or at the Southwestern Medical Foundation Medical School. The students are divided into small groups for clinics, ward rounds or clerkship service in the various hospitals connected with the Foundation, and they are drilled especially in history taking and in the technique of practical physical diagnosis.

Fourth Year

The students serve mainly as clinical clerks in the medical wards of a general hospital. They also serve as assistants in the medical clinic of the out-patient department.

The system of clinics to small groups of students affords a most effective method of studying disease and gives the student an opportunity to follow the patient from the inception of the disease to the termination of the illness. Thus the student gets a practical knowledge of the methods of studying disease and intimate knowledge of the disease itself. Especial emphasis is placed on the care of the patient as an individual with respect to diagnosis and treatment.

With individual variations in different hospitals, conferences are held for the informal discussion of clinical pathological, immunological, radiological, social or dietetic problems of selected cases.

Patients in the wards of the allied hospitals are assigned to students who are required to take the history, to make and record a complete physical examination, and discuss with the instructor the indications for, and results of, treatment.

Second Year

COURSE I—PHYSICAL DIAGNOSIS—41 hours. Two hours per week during the second and third trimesters.

The principles of physical diagnosis are covered by lectures and practical demonstrations. Practice in eliciting the normal physical signs is given and correct history taking is taught.

COURSE II—CLINICS—20 hours. One hour per week during the second and third trimesters.

In these clinics cases are presented showing the application of the fundamental sciences to clinical problems.

Third Year

COURSE III—PHYSICAL DIAGNOSIS—23 hours. Two hours per week during the first trimester.

This is a continuation of Course I. Emphasizes by lectures and practical clinical demonstrations the physical signs found in disease.

COURSE IV—THE PRINCIPLES OF MEDICINE—64 hours. Two hours per week throughout the session.

A systematic course of lectures and recitations designed to present

a general survey of the subject and correlate the work which is taken up in greater detail in other courses.

COURSE V—THERAPEUTICS—32 hours. One hour per week throughout the session.

A course of lectures and recitations dealing with the general care of patients and the treatment of certain diseases. The drugs in common use are studied in groups according to their indications in treatment.

COURSE VI—DERMATOLOGY AND SYPHILOLOGY—39 hours. One hour per week during the first and second trimesters.

This course consists of lectures, recitations, and lantern slide demonstrations covering the more important diseases of the skin and the manifestations of syphilis.

COURSE VII—CLINICAL CONFERENCE—24 hours.

Cases from the Dispensary are presented by the students in sections. Diagnosis and treatment are stressed but all phases of the cases are thoroughly discussed by the instructor and students.

COURSE VIII—ENDOCRINOLOGY—6 hours.

A course of lectures dealing with the fundamental principles of endocrinology and the endocrine conditions.

COURSE IX—WARD WORK IN GENERAL MEDICINE—248 hours.

Students are assigned in sections to medical wards where they act as clinical clerks. They take the histories of the cases assigned to them, make and record the physical examination, and present the case before the section, under the supervision of the instructor.

Fourth Year

COURSE X—CLINICS IN GENERAL MEDICINE—32 hours.

The class is divided into sections for this work.

Cases from the wards of Parkland and allied hospitals are shown and discussed before the class. The diagnosis and practical management of the cases presented are emphasized.

COURSE XI—CLINICS IN GENERAL MEDICINE.—31 hours.

Cases from the dispensary and wards are discussed before the entire class.

Professor TERRELL and Associates.

COURSE XII—WARD WORK IN GENERAL MEDICINE.—50 hours.

Students are assigned in sections to the medical wards of Parkland Hospital where they act as clinical clerks. They take the histories of the cases assigned to them, make and record the physical examination, and present the case before the section, under the supervision of the instructor.

COURSE XIII—CLINICAL CONFERENCE—27 hours.

Special conferences on Diseases of Blood, Cardio-vascular system, and acute Infectious Diseases.

COURSE XIV—GASTRO-ENTEROLOGY—12 hours. One hour per week during the first trimester.

In this course the various diseases of the digestive system are considered and their treatment by medical means is discussed.

COURSE XV—DERMATOLOGY AND SYPHILOLOGY—24 hours.

A course of clinics in which the more important diseases of the skin are presented. In this course emphasis is laid on the cutaneous manifestations and treatment of syphilis.

COURSE XVI—DISPENSARY SECTION WORK IN DERMATOLOGY AND SYPHILOLOGY—20 hours.

This course affords abundant opportunity to demonstrate the clinical appearances, diagnosis, and treatment of the various skin diseases, including syphilis.

COURSE XVII—DISPENSARY SECTION WORK IN GENERAL MEDICINE—61 hours.

The class is divided into small sections and assigned to the Dispensary, where histories are taken, patients examined, and treatment suggested under supervision of the instructor.

COURSE XVIII—TUBERCULOSIS—14 hours.

This course consists of clinical lectures and dispensary work. It

supplements the teaching on tuberculosis in the course in general medicine.

COURSE XIX—ELECTROCARDIOGRAPHY—6 hours.

Special lectures are given to the entire class.

COURSE XX—DIETETICS—6 hours.

Special lectures are given to the entire class.

COURSE XXI—ALLERGY—16 hours.

Special lectures, clinics and dispensary section work.

Professor BLACK and Instructor SHUEY.

COURSE XXII—MEDICAL JURISPRUDENCE—12 hours. One hour per week during the first trimester.

This course covers medical evidence and testimony, dying declarations, rights of medical witnesses, establishing identity from living and dead bodies, sudden death from natural causes, and by violence, criminal acts determined by medical knowledge, the legal relations of physicians to patients and the public, insanity, malpractice, the anti-narcotic laws, and workmen's compensation insurance. The medico-legal aspects of Toxicology are fully covered in the course of Pharmacology.

Second Year

COURSE I—PRINCIPLES OF SURGERY—20 hours. Two hours per week during the third trimester.

This course serves to introduce the student to the fundamental principles of surgery and surgical technique, and presents the more frequently used minor surgical procedures in some detail. Emphasis is placed on the principles and practice of aseptic technique, treatment of wounds, burns and surgical infections.

Associate Professor DUCKETT.

COURSE II—INTRODUCTION TO RADIOLOGY—8 hours. During the third trimester.

A didactic course in the basic theories of physics and biology as related to the use of X-ray and radium in clinical medicine. While this course is essentially theoretical in nature its motive is entirely

practical in order to prepare the student for his subsequent clinical studies.

Professor MARTIN and Assistants.

Third Year

COURSE III—SYSTEMATIC SURGERY—64 hours. Two hours per week throughout the session.

Lectures and recitations covering the surgical conditions of the various systems.

Professor and Assistants.

COURSE IV—UROLOGY—23 hours. One hour per week during the first and second trimesters.

This course consists of lectures and recitations, supplemented by demonstrations of the cystoscope and other instruments used in urologic diagnosis and treatment.

Professor FOLSOM and Associate Professor ALEXANDER.

COURSE V—OPERATIVE SURGERY—30 hours. Three hours per week during the third trimester.

Students are first taught the names and uses of the various instruments and surgical supplies, after which, in groups, they perform operations upon animals under general anaesthesia, observing strict aseptic precautions. Certain operative procedures are demonstrated on the cadaver.

Professor WEAVER and Associates.

COURSE VI—ANAESTHESIA—10 hours. One hour per week during the third trimester.

This course consists of lectures, recitations, and practical demonstrations covering methods of use, effects of the different anaesthetics, etc.

Assistant Professor DUPUY.

COURSE VII—FRACTURES AND DISLOCATIONS—10 hours. One hour a week during the third trimester.

Lectures and demonstrations covering the methods of diagnosis, reduction and treatment of the more common fractures and dislocations.

Professor CARRELL and Associate Professor DRIVER.

COURSE VIII—WARD WORK IN GENERAL SURGERY—244 hours.

Students are assigned in sections to the surgical wards of Parkland Hospital where they act as clinical clerks. They take histories of the cases assigned to them, make records of the physical examination,

and discuss the cases with instructors assigned to the various wards. Conferences or quiz sections on required reading are held twice weekly.

Members of the STAFF.

COURSE IX—RADIOLOGY—31 hours. One hour per week throughout the session.

The lectures in the first trimester are devoted principally to radiation therapy, its application to tumors and inflammatory tissues both being carefully elucidated. The remaining lectures are devoted to a practical consideration of the clinical use of X-ray for diagnostic purposes. The organization of the outline is concerned directly and entirely with work of everyday clinical medicine. These lectures are designed as a background for the clinical work of the fourth year. Lantern slides and original films are used for demonstration purposes. Case reports are offered whenever indicated.

PROFESSOR MARTIN and Assistants.

Fourth Year

COURSE X—ORTHOPEDIC SURGERY—30 hours.

The course is planned to provide the medical student with fundamental information about reactions of bones and joints to injury and disease. Six lectures on fractures and 8 lectures on diseases of bones and joints are given during the junior year.

Ample opportunity is given to small sections of junior and senior classmen to follow through in physical diagnosis and treatment plans of the commoner diseases, and to have contact with fracture treatment from the emergency room, to the follow-up clinic in the out-patient department.

Students attending the emergency room will have telephone contact. The out-patient clinic, two hours per week. Ward rounds, twice per week. All at Parkland Hospital. Ward round, one hour per week at the Scottish Rite Hospital for Crippled Children.

COURSE XI—CLINICAL SURGERY—4 hours. One hour per week to sections of the class.

This course is given at Parkland Hospital and deals largely with traumatic surgery.

Professors HUDSON and WEAVER.

COURSE XII—SURGICAL DISPENSARY—24 hours. Parkland Hospital.

Out-patient histories are first taken and complete physical examinations are made by students, after which instructive pathologic conditions are demonstrated to the section by the instructor. Students do most of the dressing and treatments under direct supervision. On

occasion important house cases are brought down for discussion by attending members of staff.

COURSE XIII—SURGICAL CLINIC—32 hours. One hour per week.

Formal clinic based on one or more current house cases. This clinic is to be given by one of the senior staff members and attended by both senior and junior students.

COURSE XIV—CLINICAL UROLOGY—4 hours.

Clinical lectures and demonstrations as well as operations form the basis of this course, which utilizes material from the dispensary and hospitals.

Professor FOLSOM and Associates.

COURSE XV—UROLOGY DISPENSARY—24 hours. Parkland Hospital.

The cases coming to the dispensary are used to teach routine methods of examination and treatment.

Members of the STAFF.

COURSE XVI—RADIOLOGY DISPENSARY—20 hours.

Small sections of the class are assigned to the radiology service for practical demonstrations and experience in reading of films.

Professor MARTIN and Assistants.

COURSE XVII—TUMOR CLINICS—32 hours. One hour per week throughout the session.

Special emphasis is placed on malignant tumors and their treatment. These discussions are introduced and carried on by groups of the teaching staff from all of the related departments. Patients from the tumor clinic dispensary are used for demonstration purposes. Return visits and follow-up histories are utilized whenever possible.

COURSE XVIII—NEUROLOGICAL SURGERY—CLINICAL CONFERENCES—10 hours. One hour per week to entire class during second trimester.

Clinical conferences and demonstrations covering the principles of surgery of the brain and spinal cord and management of head injuries.

COURSE XIX—PROCTOLOGY—36 hours (three courses).

Eight weekly clinical lectures in second trimester covering the diagnosis and surgical management of diseases of the anus, rectum and colon.

Professor ROSSER and Assistant Professor KERR.

CLINICAL PROCTOLOGY—Parkland Hospital amphitheater. One hour per week during the entire session to sections of the class.

Material from the dispensary at Parkland is utilized for lectures, demonstration and operations. Emphasis is laid on such conditions as are commonly seen by the general practitioner.

PROCTOLOGY DISPENSARY—Parkland Hospital.

Clinical histories are taken and examinations made by the staff and students. Pathological reports are demonstrated to the section by the instructor.

COURSE I—THE PRINCIPLES OF GYNECOLOGY—10 hours. One hour per week during the third trimester.

This course consists of lectures and recitations covering the principles of gynecology.

Fourth Year

COURSE II—THE PRACTICE OF GYNECOLOGY—12 hours. One hour per week during the first trimester.

This course consists of lectures and recitations. All diseases of the female generative organs are discussed, especially from a diagnostic and prognostic viewpoint, and the treatment.

COURSE III—DISPENSARY—26 hours. Parkland Hospital.

Small sections of the class are assigned to the dispensary. The students take the histories, make examinations, and institute the necessary treatment, all under the direct supervision of the instructor.

COURSE IV—CLINICS IN HOSPITALS—20 hours.

The class is divided into sections for clinics at Parkland Hospital. In this work selected cases are presented. The students write the histories, make tentative diagnoses and recommendations as to treatment. Operative work is demonstrated.

COURSE V—WARD ROUNDS AND CLINICAL CLERKSHIP—8 hours.

Sections of the class are assigned cases in Parkland Hospital. Students are required to write the histories, make examinations and tentative diagnoses, and present the cases to the section under the direction of the instructor.

Second Year

COURSE I—INTRODUCTORY OBSTETRICS—10 hours. One hour per week during the third trimester.

Lectures, recitations, and demonstrations covering a review of the anatomy and physiology with endocrine relations to the female reproductive organs, pelvic peritoneum, and other tissues and the external genitalia.

Third Year

COURSE II—THE PHYSIOLOGY OF PREGNANCY, LABOR AND THE PUERPERIUM—85 hours. Three hours per week throughout the first and second trimesters. Two hours per week throughout the third trimester.

Toward the close of this course the students will be given an opportunity to witness the management of labor and to observe the technique, which will give them some practical knowledge to be applied in the senior year.

Here the student receives the practical instruction in the prenatal care of the patient, measuring the pelvis and fetus, diagnosing positions, recognizing existing pathology and abnormalities.

COURSE V—PRACTICAL OBSTETRICS.

Senior students are assigned in rotation, each student serving for a period of two weeks at a time. Many of the cases are delivered in the homes. The students, while on this service, will answer calls, take careful histories, make physical examinations, diagnose presentations and positions, which will be confirmed by a member of the staff and checked up at delivery. All deliveries are conducted by the students, under the supervision of the Assistant Resident in Obstetrics, Parkland Hospital. Any unusual developments or abnormalities are reported to the Chairman of the Department. A report of each confinement, prenatal and puerperal, is made by the student and kept on file in the college office. Daily visits are made to the puerperal patient and the new born child, these visits to cover ten or more days, as the case requires.

Fourth Year

COURSE I—OPHTHALMOLOGY—12 hours. One hour per week during the first trimester.

This course consists of lectures, recitations, and demonstrations covering the more common and more important diseases of the eye. Special emphasis is placed on such conditions as are commonly seen by the general practitioner.

COURSE II—OTO-LARYNGOLOGY—11 hours. One hour per week during the first trimester.

Lectures, recitations, and demonstrations covering the more common and more important diseases of the ear, nose, and throat, with special emphasis on such conditions as are commonly seen by the general practitioner.

COURSE III—CLINICS—8 hours.

The class is divided into sections for this course. Many varied pathological conditions affecting the eye, ear, nose, and throat are presented to the students and discussed thoroughly. The diagnosis, treatment, and prognosis of each condition is carefully considered.

COURSE IV—DISPENSARY-OPHTHALMOLOGY AND OTO-LARYNGOLOGY—36 hours.

The class is divided into small sections. On entering the clinic, the students are given a review on taking a brief, practical ear, nose, and throat history and the instructor demonstrates the technique of a complete routine ear, nose, and throat examination, including transillumination of the maxillary and frontal sinuses and mirror examination of the naso-pharynx and larynx. The students are taught how to use the head mirror, the simple ear speculum, the electric otoscope, the Siegel's otoscope, the nasal speculum, and the laryngeal and post nasal mirrors.

The students are taught didactically and by demonstration, when possible, the more simple ear, nose, and throat procedures that one doing general practice in this section of the country is called upon to do.

For the benefit of the students, and particularly for the interne or resident on the service, a library of pathological specimens (gross and microscopic) will be developed and kept available at all times.

Many varied pathological conditions affecting the eye are presented to the students and discussed thoroughly. The diagnosis, treatment, and prognosis of each condition are carefully considered.

Operative clinics and ward rounds are held twice weekly. The students may witness various operations on the eye and observe the patient during recovery.

Second Year

COURSE I—PSYCHOBIOLOGY—8 hours. One hour per week during the second trimester.

Lectures covering the essentials of psychobiology.

COURSE II—PSYCHOPATHOLOGY—9 hours. One hour per week during the third trimester.

Lectures and clinical demonstrations. Emphasis is placed on the methods of examination of the psychiatric case and on an introductory elucidation of the main mental reaction types.

COURSE III—APPLIED NEUROLOGY—11 hours. One hour per week during the second trimester.

Lectures and clinical demonstrations. Emphasis is placed on the methods of neurological examination.

Third Year

COURSE IV—PSYCHIATRY—32 hours. One hour per week throughout session.

Lectures and recitations covering the diagnosis, treatment, and management of the more common mental disorders.

COURSE V—NEUROLOGY—32 hours. One hour per week throughout the session.

Lectures and recitations covering the diagnosis, pathology, and treatment of the more common and more important neurological diseases.

Fourth Year

COURSE VI—NEURO-PSYCHIATRY—DISPENSARY—24 hours.

Small sections of the class are assigned to the dispensary services of Parkland Hospital.
